M.B. Machinery Corp. (Regd.), established in 1971 in Ludhiana, India, is an ISO 9001:2015-certified manufacturer of dewatering couplings, fittings, agricultural implements, and special-purpose machinery. Led by Mr. Jagdhir Singh, a pioneer in engineering design, the company serves irrigation and dewatering industries with products like Miller, Bauer, Perrot, and Italian-type couplings, many made from CBAMregulated steel and aluminum. With exports to the EU, M.B. Machinery faced a critical challenge when a 203-ton shipment was held at customs due to a missing CBAM report. They partnered with CleanCarbon.ai to resolve the issue and establish robust CBAM compliance.



Business Challenges



- 1. Shipment Delay Due to Missing CBAM Report: A 203-ton shipment of steel and aluminum couplings was stuck at EU customs, threatening financial losses and client trust.
- 2. **Supplier Data Coordination**: Collecting Scope 1, 2, and 3 emissions data from suppliers for diverse components (e.g., couplings, fittings) was complex, requiring accurate part descriptions and HSN codes.
- 3. **Supplier Engagement**: Convincing suppliers to share emissions data was challenging due to limited CBAM awareness and trust concerns.
- 4. **Reporting Efficiency**: The variety of products generated a high volume of reports, risking administrative overload.
- 5. **Timely Compliance and Carbon Tax**: On-time, accurate reporting was essential to avoid penalties and manage carbon tax obligations under CBAM.
