India's small steel exporters are reporting the first wave of shipment seizures at European ports and order cancellations due to missing compliance reports, marking the most serious disruption yet for the country's steel micro, small and medium enterprises (MSMEs) since the European Union's (EU's) Carbon Border Adjustment Mechanism (CBAM) entered its payment phase on January 1. India was unable to secure any concession on CBAM in the free trade agreement signed with the EU on January 27. According to Nilesh Bhattad, founder of [CleanCarbon.ai](#), at least 10 Indian consignments at European ports due to missing or incomplete carbon declarations. [Read More...](#)
